#### **Subject Matter and Area Covered**

Bolsover District Council has prepared the Publication version of the Local Plan for submission to the Secretary of State for Housing, Communities and Local Government. The Publication Local Plan for Bolsover District sets out the broad spatial planning and policy framework for the whole of the District up to 2033. It includes a long-term vision and strategic objectives, land use allocations and policies that will be used to determine planning applications.

#### **Period of Publication for Representations**

Representations on the Plan can be made throughout the representation period but must be made by 5.00pm Friday 15<sup>th</sup> June 2018 to be considered duly made. Please note that anonymous representations cannot be accepted.

Where there are groups of people who share a common view, a single representation can be submitted, appending the names and addresses of those wishing to be represented.

Representations may also be accompanied by a request to be notified of any of the following:

- i. the submission of the Local Plan for independent examination under section 20 of the Act<sup>1</sup>,
- ii. the publication of the recommendations of the person appointed to carry out an independent examination of the Local Plan under section 20 of the Act, and
- iii. the adoption of the Local Plan by Bolsover District Council.

All representations received within the consultation period will be submitted to the Secretary of State together with a summary of the main issues raised and considered as part of a public examination by an independent Planning Inspector. Representations on the Publication Local Plan for Bolsover District at this stage should only be made on the grounds of legal and procedural compliance, soundness and whether the Plan is in conformity with the Duty to Co-operate.
