(ii) Report of the Police Representative

(i) No police representative was present at the meeting. The Clerk reported the crime statistics for December 2019 from the Police website.

(iii) Report from Community Speedwatch Initiative (if any)

A volunteer Community Speedwatch Operator reported that two Speedwatch events had been held in January. It was reported that at the event on Newboundmill Lane a total of One Hundred and Sixty-Six vehicles were counted of which twenty were monitored and two of these were found to be speeding. At the event on Rotherham Road, New Houghton, One Hundred and Fifteen vehicles were counted of which Forty-Four were monitored and Twenty of these were found to be exceeding the speed limit. The volunteer suggested that on the basis of the survey results a review of the speed signage on Rotherham Road could be undertaken to provide more frequent and prominent reminders of the speed limit on Rotherham Road. It was also reported that at present there is a team of seven volunteer operators involved in the Pleasley Parish scheme. It was

<u>RESOLVED</u> that the report be noted and that the County Councillor will request a review of the signage by the Derbyshire County Council Highways Team

(iv) Report of the County Councillor

Councillor Dale reported that the County Council plan to increase the Council Tax by 2% for 2020/21 which will be used exclusively on services for older people. She also reported that approval had been given to increase the Band D precept by £10 in 2020/21 to increase the funding for Derbyshire Constabulary. It was also reported that seven County Council operated care homes are scheduled to be closed and three will be refurbished. She also reported on a meeting with Mark Fletcher, MP for Bolsover, who had indicated his support for further investigation into the possibility of a Glapwell bypass and had requested costing details from the County Council for the project. It was also reported that Countryside Services has been incorporated into the Highways Team.

Councillor Allen requested that the County Councillor reports six street lighting columns which are not working on Rotherham Road.

(v) Report of the District Councillor

District Councillor T Kirkham reported that a large amount of dog waste had been cleared from the Welfare Path. It was also reported that work towards the New Houghton Hub is progressing and there are plans for the group to open a bank account. He reported that it is hoped that the New Houghton Hub will get a lease for the building previously used by the Freedom Group, and that there are plans for a new boiler to be fitted. It was also reported that he had attended a talk at Sports Direct on automation and it is anticipated that over the next ten to fifteen years thirty per cent of jobs will be lost to automation. He also reported that he has arranged a meeting with the leader of the District Council to try and

get support for a training college in the area for Information and Communications Technology (ICT) skills training.
