#### **RECYCLING**

**Over 80,000 households** across Bolsover District and North East Derbyshire District will be able to recycle more waste as food and drink cartons and shredded paper can be disposed of through their burgundy bins from 1 November 2015. Food and drink cartons may be placed in the main part of the burgundy bins and shredded paper in the bottom of caddies weighted down by other papers and magazines.

As part of the recycling schemes an extension to the burgundy bin contracts have been negotiated that will see the addition of this type of material and provide residents with the opportunity to recycle even more of their household rubbish.

A vacancy has arisen for a Clerk/Responsible Financial Officer for Pleasley Parish Council.. The successful candidate will be responsible for keeping the council's clerical and financial records. An office is provided the Verney Intitute Pleasley and by arrangement the Clerk may also work from home.

The successful applicant if not already familiar with local government law, procedure and finance, including payroll and audit will be expected to take Clerk Induction Training with DALC

It was the first anniversary of the **Freedom Community Project in New Houghton** at

which Cllr Howard Wright along with Dennis Skinner MP was invited to attended this celebration along with other members of various organisations.

District Councillor Pauline Bowmer also attended this first anniversary.

It was good to see this building being used for the benefit of the people of our parish for such a worthy project.

<u>Freedom Community</u> is a charity working together to help residents' lives change. This new venture in New Houghton is working very well and is having very good reports.

It has its regular visitors who meet daily to exchange pleasantries over a cup of tea and talk about local family life. It was good to see so many people who appreciated this venture. Dennis Skinner and Cllr Wright spoke to residents and organisers alike; Dennis even gave them a rendering of songs "my Mother used to sing" much to the surprise of those present.

This project is supported by local volunteers who give their time freely to help run this successfully and credit is due to them.

Freedom Support helps in many ways.

Food Bank is from Monday to Friday 10am to 2pm. Its aim is to support those who are unable to buy food by providing an emergency supply of food. It is operated on a referral basis. Free Café everyday from 10am to 2pm provides a relaxed atmosphere where people can meet where you can find free help and support. The **2 Shires Credit Union** runs a drop in where you can arrange a savings account, deposits, withdrawals, small loans and repayments.

Help is provided for those with debt and/or benefit issues, including help with budgeting, benefit checks, a self-help debt pack and where to get specialist help and advice.

There is a small friendly group aimed at providing one-to-one support for adults who struggle with reading and writing. There is a team of volunteers who meet during term time. The clothing store is second to none and provides a selection of new and nearly new items at affordable prices, including children's, men's and ladies' clothing and accessories. There are furniture items too.

The client support service provides impartial help for people struggling with a range of issuers. Such as support for homelessness. Benefits, addiction and debt among others.

#### **IS THERE ANYBODY THERE**?

An interesting item, very much debatable and sceptical by many people, was brought to light recently when our village hall was hired by a group of paranormal Investigators, in other words Ghost Busters. They met to discuss their movement and schedules, very much like any other organisation might meet to discuss their movement and activities.

It was mentioned that whilst this group was in the building they could sense a presence of an unidentifiable existence dating back to the 1700s. This may be thought by many to be out of context with the building, as it was built in 1906 and therefore not applicable at all. But, on this site there was the Pleasley Parish Hall, the meeting hall for the Pleasley Parish Council and lending library which was demolished in 1905 for the new Verney Institute to be built in 1906, so is the well known phrase which so often repeated, true or false.

We will never know unless this group can make further contact on a future visit which they are contemplating.

One of the most paranormal reports have been made at Pleasley Vale Mills.

Throughout history, many have spoken of ghosts they see in their rear view mirror as they drive away, sounds on the tracks when loads of cotton would be transported, and other ghostly sounds, creaks, and apparitions.

The male energy who is thought to be a supervisor e is said to have committed murder, which led to a murdered woman feeling distraught and showing herself on the top floor, especially in and around the dye room.

Many mediums have picked up on the fact that he committed murder and rape during life on the premises.

Are all the ghosts centred on Hollins and this supervisor and this treatment or could they be from the prehistoric inhabitants that lived in the cave below? If you should happen to visit, pay close attention, you may be the one to help solve the mysteries that have forever left Pleasley Vale Mills haunted.

#### **NEW HOUGHTON COMMUNITY CENTRE**

The parish council has had problems with blocked toilets at the Community Centre, the reason being, tree roots from a neighbouring property. The roots are seeking moisture to feed and have infiltrated through the pipe joints into the pipes blocking the drainage system.

The drains have been cleared. The offending tree is to be taken down in the very near future.

The emergency exit was also impassable because of overhanging bushes, this has been rectified.

# What do I do when I receive the NIP (Notice of Intended Prosecution)?

You are required to identify the driver of the vehicle. You must do this within 28 days and if you fail to do so, you have committed a further offence for which your licence can be endorsed with 6 penalty points and a fine up of £1,000 imposed, unless you can show that it is impossible to comply despite your best reasonable and diligent enquires to establish the driver's identity.

#### What are the rules regarding the N.I.P.?

For certain offences, the process can be started by serving a Notice of Intended Prosecution Pursuant to Section 1 of the Road Traffic Offenders Act. Typically, these offences are speeding, failing to comply with traffic signals etc.

The obligation is upon the prosecution to have issued and dispatched the Notice in order that it arrives with the registered keeper of the vehicle within 14 days of the offence.

Service can be by first class post, by hand or in some circumstances, by recorded delivery. The method of delivery is at the discretion of the prosecution who only have to show that they have followed the correct procedure.

The Notice must be signed (although this can be typed) on behalf of the Chief Constable, typically it will simply name an authorised officer, dated and contain sufficient information for the offence to be identified.

#### What is the 14 day rule?

The 14 day rule relates only to the period of time in which the Police/Process Unit must serve the original Notice.

The Police do not have to prove that the Notice reached its intended recipient within 14 days, merely that they believe that it arrived, but there may be a defence available if the intended recipient can convince a Court that the notice did not arrive in time or at all.

In many cases, the registered keeper will be a lease company not the actual driver, with the result that even if the driver is unaware of the incident, service of the Notice is good if it was sent to arrive at the registered keeper's last known address within 14 days of the offence. If the N.I.P. was issued out of time, what can I do? If you are the registered keeper of the vehicle and the ISSUE date on the Notice of Intended prosecution is more than 14 days after the ofThis only applies if it is dated more than 14 days after the alleged offence. If the NIP has been issued too late, then you should return it to the Process Office stating that you reject it because it is time barred. Bear in mind that if you are not the registered keeper, the NIP may have originally been issued within time and sent to the keeper.

What if the incorrect details have been quoted such as; model of car. Road Name have been quoted on the N.I.P.?

If the matter can be identified, regardless of the error, then you still have an obligation to reply. If the error means that you are unable to substantiate the allegation, you should return the Notice asking for clarification. An error would not immediately mean the Notice is null and void.

#### Tickets issued over the 14 day limit

If the issue date of the NIP sent to you was more than 14 days after the alleged offence took place, than you can refuse to accept it on the basis that it is time barred. This is certainly true in your case and if you appeal against the ticket on these grounds you should have no problem getting the ticket cancelled."

#### General Garden Tasks for Now.

Now the ground becomes vacant, you can dig it over and spread manure over the surface. Leave the soil roughly dug in large clumps and the worms will break these up as they get the manure. The freezing and thawing of water in the soil will cause the soil to break up finely so becoming easier to handle in the spring.

Digging over introduces air into the soil, loosening it and avoiding it turning into a solid pan. It also exposes insect pests to the open air where the birds can eat them. Double or deep digging and introducing manure or composts to the base of the trenches will deepen your top soil providing a better growing medium.

#### With light, sandy soils digging every year is not needed but heavy soils really benefit from it. It's also the time to lime as required but don't add lime and manure at the same time.

If you're making a bean trench, keep on filling it, adding a little soil over each layer of kitchen waste as you go.

Now is a good month to attend to pruning the raspberries, blackberries and hybrid berries as well as being the ideal time to plant bare rooted canes. Don't forget to add plenty of compost to the soil and 250gr (8oz) per square yard of bone-
